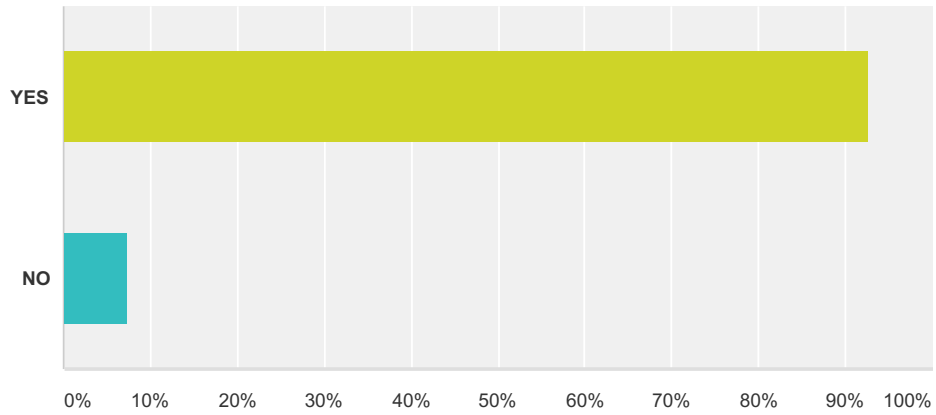

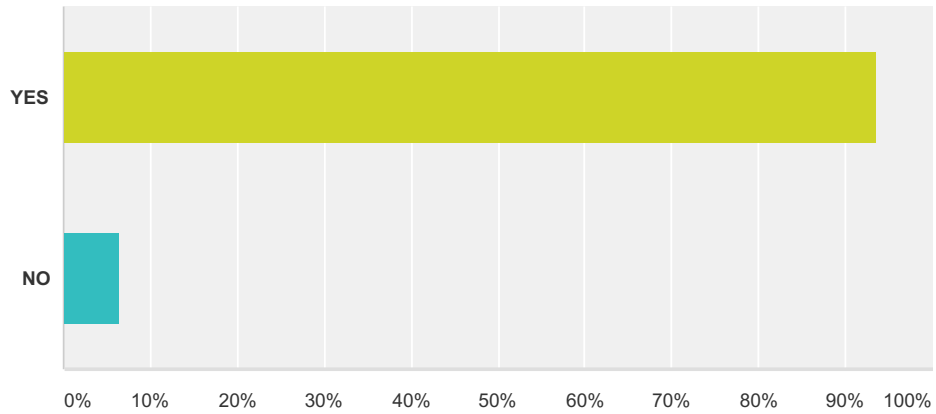

Q2 Do you agree that good quality roads in Wolf Laurel improve property values, safety, and accessibility for Wolf Laurel stakeholders?

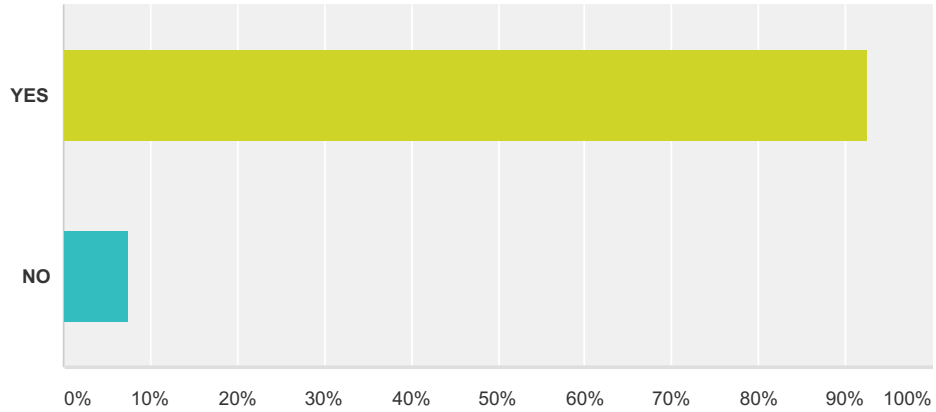

Q3 Do you agree that maintaining Wolf Laurel as a private, gated community supports higher property values and quality of life?

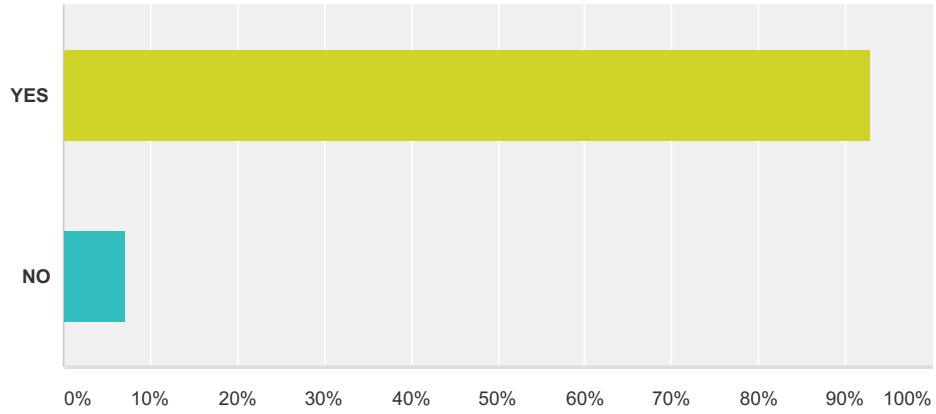

Q4 Do you agree that fair and transparently enforced covenants support higher property standards and values, and higher quality of life in Wolf Laurel?

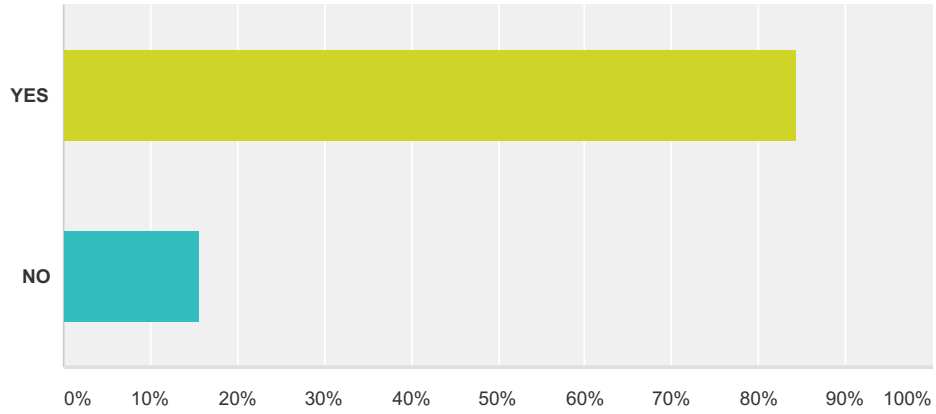

Q5 Do you agree that an active and reasonable Architectural Review Board helps maintain Wolf Laurel's community standards and property values?

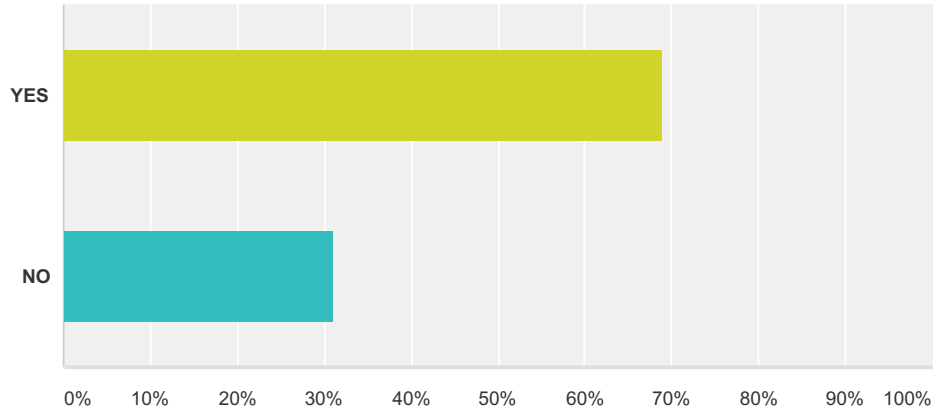

Q6 Have you ever sought assistance or information from the on-site, year-round WLRMS Security Staff?

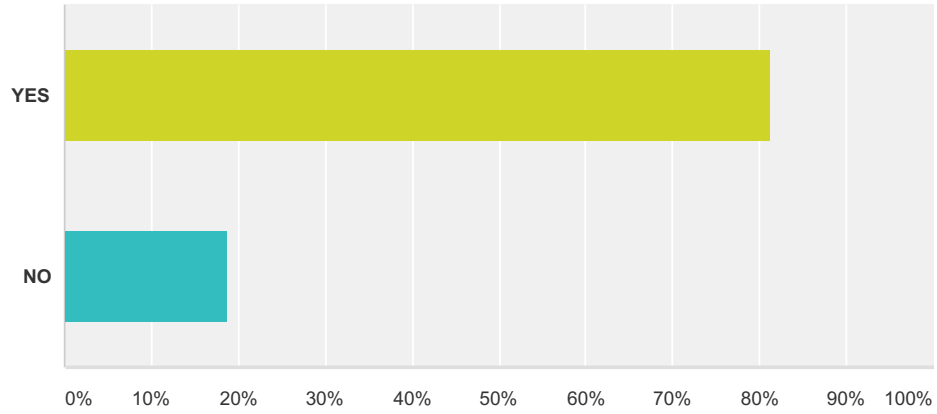

Q7 Do you know that monthly WLRMS Board of Directors' meetings are open to all Wolf Laurel stakeholders?

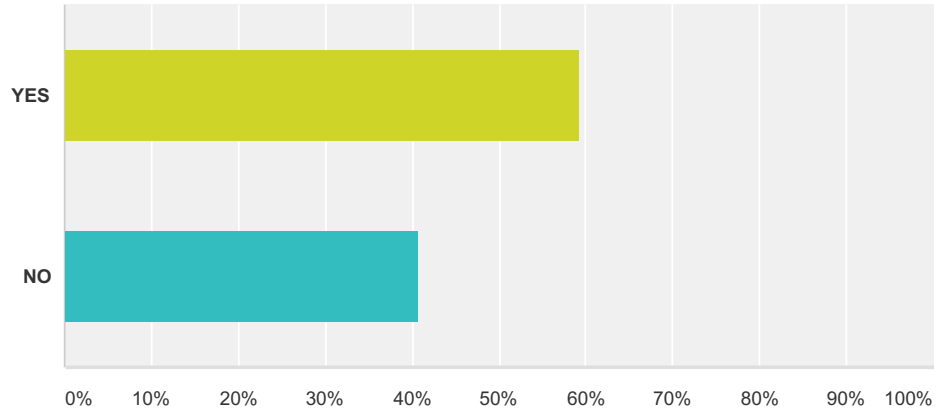

Q8 Do you know that a public comment session is held at every WLRMS Board of Directors' meeting?

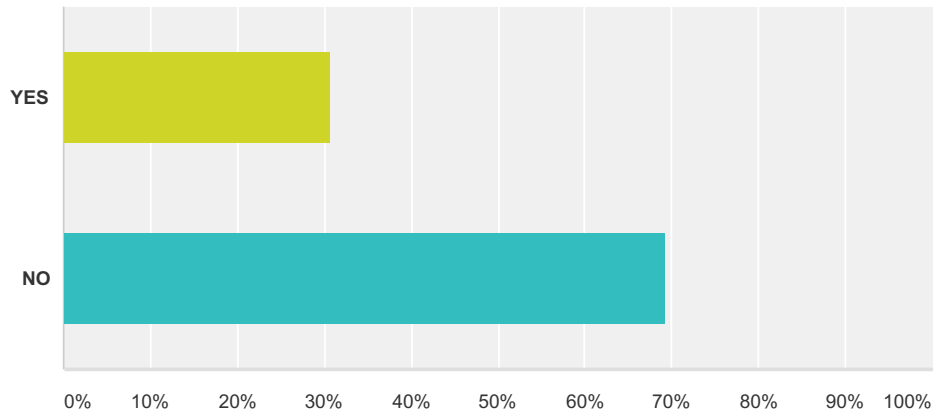

Q9 Have you ever attended a WLRMS Board of Directors' meeting?

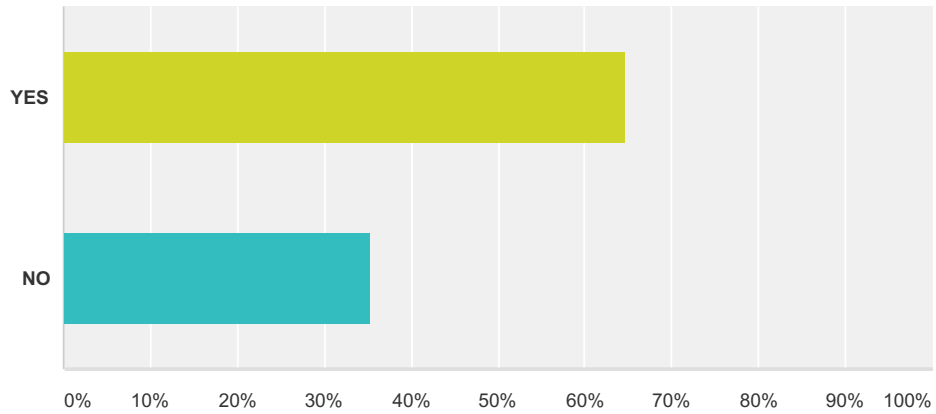

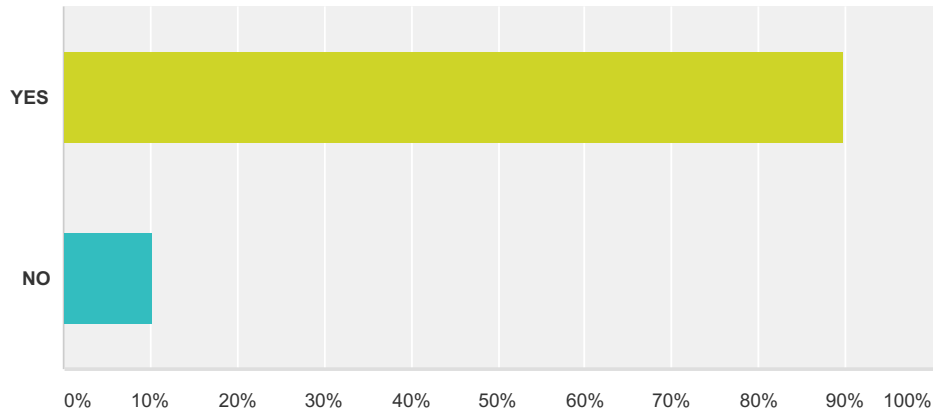

Q11 Do you support the development of an inclusive Long Range Plan to help ensure financial stability and operational excellence for all communities within Wolf Laurel?

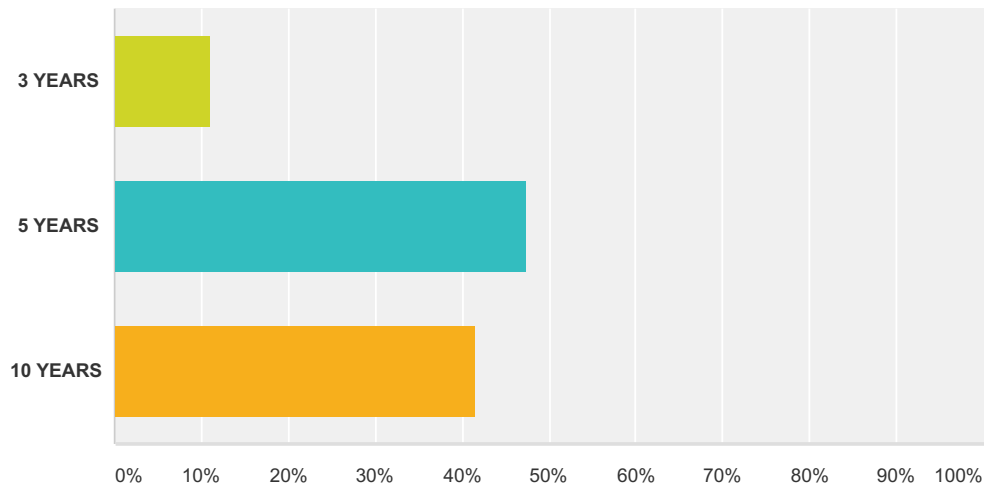

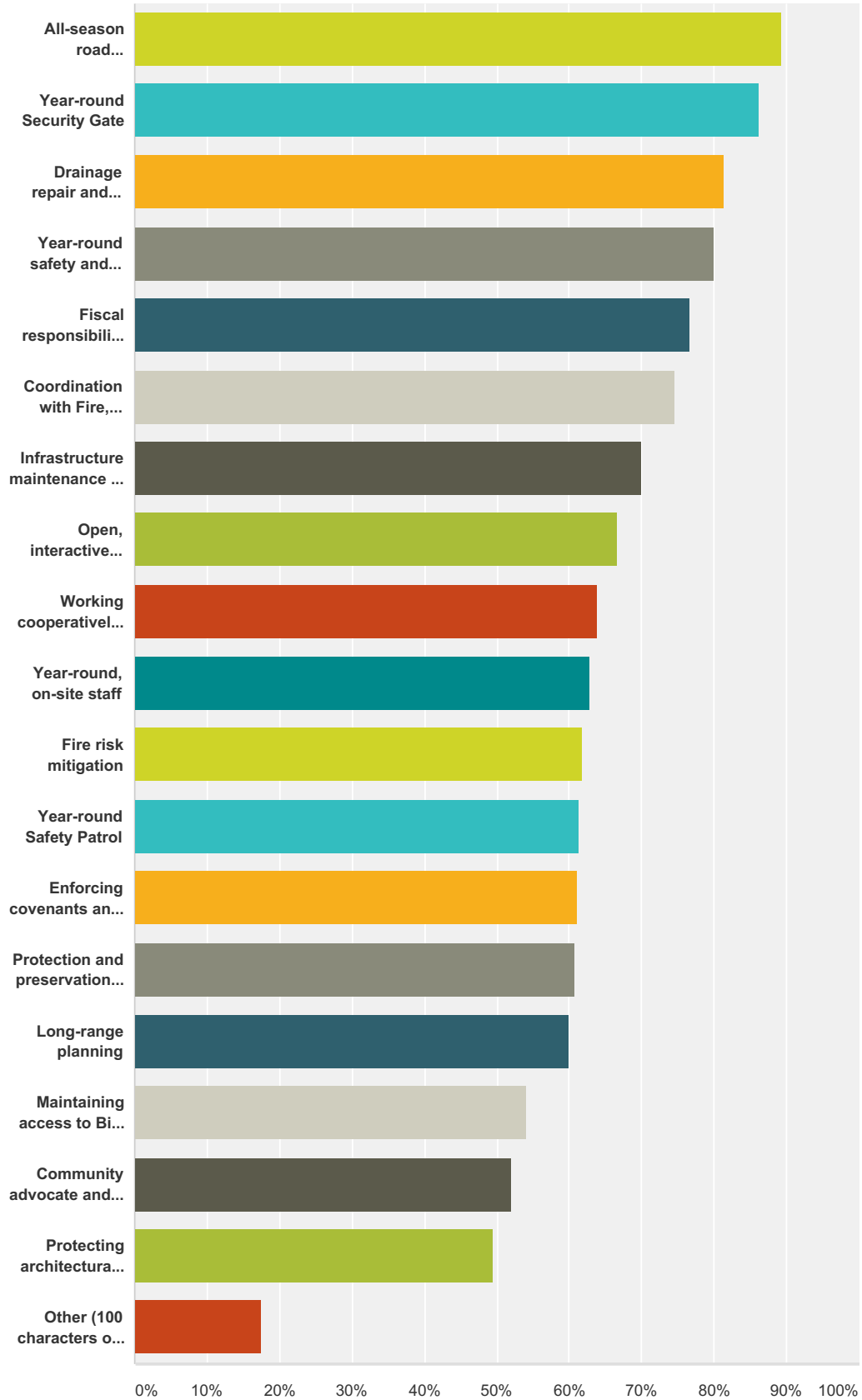
